(45) Truck Driver: Temporary, Full Time. Min. \$27.33/hour, at least 36 hours/week, varying 12-hour day and night shifts. Work week and shift start times are variable. Additional hours/days may be available based upon company needs. All hours worked over 36 hours/week will be paid at a straight time rate of \$27.33/hour. Employer will use a single workweek as its standard for computing wages due. The employer will make all deductions from worker's paycheck required by law. Wages will be paid weekly. Employment period October 1, 2026, to March 1, 2027. The workers under this application will work in proximity of 1320 East Railroad Avenue, Fort Morgan, CO 80701 as well as other locations within the Eastern and Southern Colorado nonmetropolitan area including the counties of Yuma, Sedgwick, Phillips, Morgan, Washington and Logan. The workers may also work in Larimer County and Weld County, which are in the Fort Collins and the Greeley Colorado MSAs.

Optional furnished housing, utilities and use of shared vehicle from housing location to dispatch location are available on a limited first-come first-served basis at a cost of \$235.00 per worked week which will be deducted from weekly paycheck.

Drive tractor-trailer trucks transporting agricultural commodity (sugar beets). Regularly climb up and down, on, into and out of tractors and trailers, up to 5 feet high. Must be able to read, write, and speak English sufficiently to perform job duties, including reading traffic signs, communicating with the public and law enforcement, and completing required reports in accordance with DOT and FMCSA requirements. Able to sit and remain alert while driving for an aggregate period of up to 11 hours. Must pass background check and drug testing. English proficiency required to perform job duties. Minimum 12 months Truck Driver experience and a Commercial Driver's License or equivalent is required. No education requirements. No OJT.

If the worker completes 50 percent of the work contract period, the employer will reimburse the worker for transportation and subsistence from the place of recruitment to the place of work. Upon completion of the work contract or where the worker is dismissed earlier, the employer will pay for the worker's reasonable costs of return transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer or where the employer has appropriately reported a worker's voluntary abandonment of employment. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence will be provided at a rate of at least \$16.78 per day during travel to a maximum of \$68.00 per day with receipts.

Workers will be reimbursed in the first workweek for all visa, visa processing, border crossing and other related fees, including those mandated by the government (except passport fees). The employer will provide workers at no charge with all tools, supplies, and equipment required to perform the job. The employer guarantees to offer work for hours equal to at least three-fourths of the workdays in each 12-week period of the total employment period.
