Wrkrs will perform variety of landscaping tasks using hand/power tools/equip. Duties may inc any combo of: mowing, planting, transplanting, digging, edging, mulching, weeding, brush clearing, pruning, & trimming. Load/unload plant materials & equip. Prepare trees & shrubs for digging by tying/wrapping root balls as nec; secure w/ twine/staples, Performs any other duties involved in maint of plant materials & nursery stock & maint of holding yards/shipping areas. For any nursery-related duties, wrkrs will use a majority of plant materials & nursery stock not grown by emplr

Must lift/carry 50 lbs., when necessary. Saturday work required, when necessary

Requires three months of experience in job described

Emplr pays in adv/reimburses wrkrs in 1st workwk for all gov-mandated & visa-related fees (exc passport fees). For non-local wrkrs (i.e., residing outside norm commuting dist), emplr reimburses inbound travel costs @ 50% point in contract (unless pd in adv). Travel reimbursements based on least-cost common carrier rate. Emplr provides/pays outbound travel costs upon completion of contract period/early dismissal, except where worker has subsequent emplmnt

Emplr guarantees to offer hours equal to at least 3/4 of workdays in ea 6-wk period of total contract period, beginning w/ workers first workday & ending on contract end date/any extension thereof. Emplr may count all hrs worked+any hours offered w/in std work sched that worker chooses to not work, up to max # of daily hrs on job order

Wrkrs who voluntarily abandon emplmnt are not entitled to payment for outbound travel costs or full three-fourths period guarantee described above

Emplr provides w/out charge all tools, supplies & equipment (incl. uniforms, if applicable) nec to perform duties assigned. If requested, emplr helps non-local wrkrs secure optional worker-pd lodging
