 Attendant will be responsible for offering exceptional service to our guests
 in our dining restaurants, banquet venues, lobby lounge, and other guest
 food and beverage venues. Assign patrons to tables suitable for their
 needs and according to rotation so that servers receive an appropriate
 number of seatings. Greet guests and seat them at tables or in waiting
 areas. Answer telephone calls and respond to inquiries or transfer calls.
 Make Dining reservations and maintain electronic data. Operate cash
 registers to accept payments for food and beverages. Greet and
 communicate to patrons, provide menus, take orders, enter orders in the
 POS systems, cash handling and proper sales documenting, maintain
 stock of foods and drinks, and maintain a professional demeanor and
 always complete tasks in an efficient and timely manner. May be required
 to take alcoholic drink orders, mix and serve drinks to patrons. Set and
 clear tables for service, maintaining sanitation and cleanliness standards.

 completion of the work contract or where the worker is dismissed earlier,
 employer will provide or pay for worker's reasonable costs of return

transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer. The employer will pay directly for and/or reimburse workers for all reasonable inbound transportation and subsistence costs within the first workweek. The employer will pay directly for and/or reimburse workers for all reasonable outbound transportation and subsistence costs during the last workweek. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence will be provided at a rate of \$16.78 per day during travel to a maximum of \$68.00 per day with receipts. The employer guarantees to offer work for hours equal to at least three fourths of the workdays in each 12-week period of the total employment period. The employer will provide workers at no charge all tools, supplies, and equipment required to perform the job. H-2B workers will be reimbursed in the first workweek for all visa, visa processing, border crossing, and other related fees, including those mandated by government (excluding passport fees).
