Goma, Inc. located at 1450 Ala Moana Blvd, Honolulu, Hawaii 96814 is hiring temporary merchandisers to work from November 14, 2026 until August 31, 2027. Work will be performed in and around Honolulu, Hawaii.

No experience required. Training will last two weeks. The Merchandiser is

responsible for promoting and selling the company's retail sauce products in the front-of-house area of the restaurant. This position supports retail sales operations by ensuring proper product presentation, maintaining sufficient stock levels, assisting customers with product information, and encouraging sales through direct customer interaction.

Must have at least a middling grasp of spoken English and a basic grasp of written English. Fluency not required.

Requirements: Ability to lift and move heavy loads (50lbs or more). Must be able to work under tight deadlines. Strong attention to detail and precise measurements. Ability to accurately follow recipes and instructions. Absolute dedication to cleanliness. Must not be allergic to nuts, shellfish, or other common food allergens.

Training is 2 weeks, not 2 months.

Work hours will vary but will usually be 8 hour shifts and will equal approximately 40 hours a week. Workers will be paid at a rate of \$19.06 per hour up to 40 hours/week and then \$28.59 per hour for overtime hours.

The employment is on a full-time temporary basis. The worker will be paid at least every two weeks. Workers will be offered lodging. If the worker accepts lodging, then the Employer will deduct the reasonable fair market value of the lodging from the worker's pay. The Employer will make all other deductions required by law.

The Employer will make all deductions required by law. Employer will use a single work week as its standard for computing wages. Employer will reimburse H-2B worker in the first week for all visa, visa processing, border crossing, and other fees as required by law. If worker travels from abroad, travel expenses will be reimbursed. If the worker completes 50% of the work contract period, employer will reimburse the worker for transportation and subsistence from the place of recruitment to the place of work. Upon completion of the work contract or where the worker is dismissed, if earlier, employer will provide or pay for workers reasonable costs of return transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to a subsequent employment with another employer. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence will be provided at a rate of \$16.78 per day during travel to a maximum of \$68.00 per day with receipts. Employer will provide all tools, supplies, and equipment necessary to complete the assigned duties. Worker is offered employment for a total number of hours equal to at least $\frac{3}{4}$ of the workdays for each 12 week period, if the period of employment is 120 or more days, or each 6 week period, if the period of employment is less than 120 days.
